INSTRUCTIONS AND IMPORTANT INFORMATION

If you are intending to call an expert witness then you must serve notice on all other parties within the following timelines, unless otherwise ordered by the Panel:

Notification of your intention to call an expert witness must be accompanied by the following information:

- 30 days before the hearing if you are the party who filed the notice of appeal; or
- 20 days before the hearing for any other party to the proceedings.

☐ The expert's name and area of expertise;
☐ The expert's qualifications, including employment, education, training and experience in his or her area of expertise;
☐ A report that sets out the expert's conclusions and the basis for those conclusions on the issues to which the expert will provide evidence to the Horse Racing Appeal Panel (HRAP);
☐ Where the expert report exceeds 12 pages (excluding photographs), a summary stating the facts and issues that are admitted and those that are in dispute, and the expert's findings and conclusions;
☐ Where the party intends to rely on or refer to the written report of the witness statement at the hearing, a copy of that report or witness statement signed by the expert witness; and
☐ An acknowledgement of expert's duty signed by the expert (see page 2, Acknowledgement of Expert's Duty).
